Compliance Is Care: 2026 Employment Law Developments for Home Care + Ask The Employment Attorney Anything!

Think employment compliance is just about paying on time? Think again. Designing and managing lawful compensation models and employee practices for field and office team members isn't optional—it's mission-critical. Yet, even the most well-intentioned agency can – through lack of knowledge or diligence – implement employment practices that create rather than eliminate risk (e.g., not using proper documentation when engaging new workers, using pay models like day rates and pay per visit without complying with legal requirements, misclassifying workers, failing to calculate the regular and overtime rate correctly, etc.). Agencies who get off on the right foot can also drift into non-compliance and fail to stay abreast of the changes to the legal and practical landscape – thereby exposing your agency to audits, costly penalties, or worse yet the inability to recruit and retain team members. And all of that is before dealing with and responding to changing employment laws at the federal, state, and local level.

In this practical (and slightly entertaining) session, our (friendly) Littler employment law attorney, Josh Vaughn, will provide updates on the U.S. DOL's Proposed Companionship & Live-In Exemptions, identify common wage and hour mistakes that get agencies sued and the fixes that actually work, identify trends in state laws in 2025 and expected in 2026, and answer your employment law questions. You'll leave with knowledge, practical steps to fix compliance mistakes, how to prepare for audits, and maybe even a few laughs—because employment law compliance doesn't have to be boring!
