OASIS E is set to be implemented on January 1st, 2023 and this will require preparation. Payment and outcomes for providers are directly impacted by OASIS data collection. It is crucial that the data accurately reflects the status of the patient. Changes to OASIS have always increased stress for all organizational levels.
